* Back net of 30m at both ends of wicket blocks @4m height

* Roof Netting set at 4m Height, 3 sections x 2 ends measuring 9m width x 25m in length with all sides to have drop down curtain netting.

* 3 x Section of 3 lane setup total 4 nets @ 4m height with all netting to move sideways for ease of wicket block preparation. of 4 nets moving to one side, This option will be replicated for both ends.

* Bowlers Run up nets at both ends 2 Nets at 16m x 4m overlap to slide to either side as well as offer the protection of turf Pitches recovering allowing area to be sectioned off.

* Entrance of bowlers runup netting will allow for Rollers and machinery 4m center of run-ups on one side only by way of netting overlap.

All netting will be manufactured in Black with machine overlock stitching and edgings of both 8mm and 20mm heavy roped edges.

Option Black & white sight screens at each end in custom manufactured shade cloth material on snap hook setup drawn to either side and the option of fixing into surface by way of pegs. Both screens will span 30m width and 4m height.

All required fittings and fixtures are supplied for each sections required.
