We do not accept any responsibility for any damage to buildings, services or surrounding landscapes as we will be working in conjunction with the property engineers & stakeholders.
- 7.** It is the client's responsibility to mark out boundaries and/or have the boundary surveyed, and services such as Phone, Power, Water & Gas must be located by the client.
- 8.** To facilitate vehicle and machine entry to the site, a suitable path is to be nominated by the client. The client is to provide ground protection mats in place if the path is soft & likely to be damaged.
- 9.** Unless otherwise specified, quotations are based on standard soil conditions for excavation. In the event of rock, hard fill or foreign material being encountered, further costs as required for excavation / earthwork will be applied.

- 13.** Site specific inductions that exceed thirty (30) minutes in length will incur a charge based on our hourly rate.
